SECTION 1: INTRODUCTION

B3 will now contribute cash dividend monthly to you in exchange for the display of advertisements in your internet cafe. SECTION 2: CASH DIVIDEND PAYOUT

Upon signing up with B3Share Business Program, the number of shares to be distributed to the customer is according to the PC units available in the customer's internet cafe. - e) The customer must display the advertisement on all client PCs' screensaver (must not turn off PC's screen) during the PCs inactivity period on daily basis. B3 may issue warning letter to customer who have failed in doing so, and once the problem still persist after the warning letter had been issued, B3 shall have the right to declare the shares held by the customer to be void and customer may subjected to penalty of not more than one hundred (100) Ringgit Malaysia per share times number of months (total period of failing to display the advertisements)
